## Macksburg City Council Minutes

The Macksburg City Council met on March 2, 2015 at 7:00 p.m. Pro Tem Mayor Michael Carlson called the meeting to order. Roll call was taken. City Council members present- Bates, Peckham, Shady, Carlson and Jones. Mayor Ruth Eivins absent from meeting. Citizens attending - Rick Bruett, Bob McKinney, Travis Witt and Becky Faust.

Agenda reviewed. Bates motioned to approve agenda with amendment to add budget discussion to the agenda; Jones seconded and carried with all ayes.

Becky Faust approached City Council about snow removal on Church St. in Macksburg Iowa. Becky advised that Church St. is not always being plowed. Council advised Faust that if it happens again to contact, City Clerk, or Street committee members Carlson, or Shady.

Bob McKinney approached City Council about water in his yard due to run off from Co-op. Travis Witt spoke also to the council about the reason why is the gravel being washed down from the co-op culvert. The March bills totaled \$1029.70. General Fund Total \$1029.70 RUT Fund Total \$0. Bates made a motion to approve January's bills; Peckham seconded and all carried with ayes.
